Essentiality Certificate

Most of the posts sanctioned by Government in various Health Departments against the vacancy of Nurse remain vacant especially in rural/difficult areas due to critical shortage of Nurses-Human Resources availability in the stage. The short fall of nurse is estimated to be 80% and this affects the coverage and quality of health services being provided by the Government to its citizens. The reason behind this is non availability of enough seats in nursing courses. By the enhancement of seats in nursing institution, it will definitely improve the nurse man power in the state by producing diploma, graduate and post-graduate professionals which will minimize the deficiency of qualified nurses/faculty.

2- On careful consideration of the proposal, Government of Uttarakhand has decided to issue an essentiality certificate to **start fresh course 30 seats for G.N.M in Divine College of Nursing and Paramedical Science, Shyampur Haridwar** for the year 2023-24 under following terms and condition:-

- i. The institution shall complete the required Ownership, Valid Resolution till the time of I.N.C. inspection.
- ii. A memorandum of understanding shall be signed between the applicant and the Medical Education Department, Uttarakhand Government for 50% State Quota in all nursing programmes applied by the applicant.
- iii. Institution will fulfil all the rule-regulation/norms of I.N.C., State Government, State Nursing Council and State Medical Faculty before admission otherwise; state shall have the power to cancel the Essentiality Certificate/affiliation.
- iv. The institute will take the permission/affiliation form State Nursing Council and State Medical Faculty before admitting the students in enhanced seats or for new course.
- v. The institute shall abide by the rule-regulation/norms issued by I.N.C., State Nursing Council and State Medical Faculty from time to time.
- vi. The Institution shall Complete the all norms (Faculty, Hostel, Fee fixation Etc.) before I.N.C. Inspection

Otherwise Essentiality Automatically will be deemed as cancelled.

- vii. The Institution will provide Tehsildar report and affidavit regarding land and building along with the approved map to the Director of Medical Education prior to the inspection of I.N.C.

3- It is further certified that:

- a. It is desirable to run the Nursing programs in the interest of public.
- b. Adequate clinical material as per the Indian Nursing Council norms is available. It is further certified that in case the applicant fails to create infrastructure both clinical and teaching for the School/College of Nursing as per INC norms then the fresh admission would be stopped by the State Government and INC.
